

All-Con 2013 Talent Agreement

All-Con, LLC, a corporation in the state of Texas, is operating a fan-based convention named "All-Con". All-Con has signed the contract for the public spaces and private room blocks at the Crowne Plaza Hotel - North, located at 14315 Midway Road, in Addison Texas, for the dates of March 8th, 9th, and 10th of 2013. This agreement is for the Talent guest signed below to actively participate in the events and activities of the convention which includes interaction with the convention organizers, promoters, and attendees.

Part I - Expectations of Talent:

Use of Name and Likeness

During the promotion and operation of the convention, Talent's name will be used in the capacity of "Special Guest" being featured as participating with the convention. No Talent endorsements, affiliations, or sponsorships will be stated or implied by the convention. Talent will supply convention up to three different unsigned publicity or studio photographs reproducible to promote guest's appearance at the 2013 convention.

Convention Attendance

Unless escorted by All-Con Organization Staff, Talent are expected to remain on the hotel property and in convention areas during the convention.

Panel Hosting

A minimum of one 50-minute "panel" discussion will be lead by the Talent, to be scheduled by convention organizers. Panels should focus on topics the talent is professionally employed around or considered to be an authority in. A 50-minute panel should be planned as 40 to 45 minutes of speaking, followed by 5-10 minutes of questions and answers. Talent is welcome to promote their own venue of products or services the last 5 minutes of the panel.

Venue Attendance

Talent will be provided a space with a table and chairs with which they may promote themselves and their works, and will be available to be approached at no cost, in a controlled method, by attendees of the convention. This space may also be used by the Talent for the sale of their own merchandise, or services such as signing autographs. Autograph prices are to be set in advance by each individual Talent guest. All revenues generated by Talent guests at their own venue will be retained by the guest. All-Con does not supply any materials, including photographs, for celebrity autograph purposes. Guests are required to bring their own in sufficient supply for the event.

Activity Volunteering

During the course of the convention, there will be many opportunities for Talent volunteers. (Master of Ceremonies, costume competition judges, live shadow-casting performances; convention program content contributions; etc.) Talent should be approachable to be asked by convention organizers to volunteer for any variety of activities. Talent is not required to accept volunteer requests. Sincere consideration of requests is appreciated.

Volunteer Appreciation

All-Con's support structure is based upon at-large volunteers. Talent is asked to provide, free of charge, 10 non-personalized autograph signatures explicitly for the distribution to All-Con volunteers at the appreciation event, at the conclusion of the main convention.

Advance Preparations

Panel topics and autograph prices need to be confirmed before February 1, 2013, and may be printed in the official Convention Event Program.



Part II - Convention Gratuity:

<u>Travel</u>

Round-trip travel will be arranged for the Talent guest between their nearest major metropolitan city and Dallas, Texas. Ground transportation will be provided between the Dallas airport and the convention hotel. Transportation for Talent originating outside the state of Texas will be coach-class airfare. Once the travel itinerary has been agreed upon, Talent is responsible for any additional charges incurred by changes in the itinerary that are made at their request. All-Con will reimburse Talent for actual costs (fuel, parking, cash tips, etc.) required to reach their airport of origin, with a maximum reimbursement of \$100 per direction. Receipts are required prior to reimbursement.

Room

Each night that Talent is present at the hotel for the purposes of the convention, they will be provided one guest room on-site at the convention hotel.

Meals

The convention organizers will provide meals at the hotel restaurant. Access to the Hospitality suite is also available during convention operation hours.

<u>Venue</u>

During autograph hours Talent will be provided their own table and a convention assistant. The autograph area will be preconfigured with universal room decor. From this space, Talent may conduct any business, sales, or promotions to convention attendees. All monies generated at this venue will be retained by Talent. During the overnight, cash may be stored in the convention's lockbox, or Talent may secure it by their own means.

<u>Security</u>

All-Con provides a security presence throughout the convention. Please contact the convention organizers with any specific security requests.

Part III - Exclusive Audience:

Texas Appearances

To protect All-Con's investment in celebrity for fan attendance, Talent agrees to make All-Con an exclusive appearance at "conventions" for a period of 30 days before and after March 8th 2013, for a distance of 50 miles from the convention hotel.

Part IV - Cancellation of Agreement:

By contract with the hotel, All-Con is a non-cancellable event. Talent may be released from this agreement without recourse at any time for professional commitments, and will notify All-Con organizers within 48 hours of discovery if this commitment cannot be kept.

Part V - Authorized Signatures:
